Terms and Conditions:

By submitting your registration form and payment to VP Productions Travel, you acknowledge and agree that you fully understand and accept the terms and conditions outlined below.

Communication Before the Trip

VP Productions Travel, LLC will contact travelers after a deposit and monthly payments have been made. If email communication is not possible, we will reach out via phone or mail. Travel documents will generally be sent 14-21 days before departure. VP Productions Travel will cover the cost of mailing these documents through the United States Postal Service. All emails and phone calls to VP Productions Travel will be responded to within 24 hours. Once at your destination, VP Productions staff will be available to assist you with any questions or concerns on both arrival and departure days.

Deposits and Payments

Payments can be made via Cash App, Zelle, Debit or Credit card (online), check, money order, or cashier's check. Please make checks payable to VP Productions Travel and mail them to:

Late Fees and Cancellation Policy

Note: All deposits are non-refundable.

The policies outlined below apply to all trips organized by VP Productions Travel, LLC unless specified otherwise in writing. VP Productions reserves the right to amend these policies with prior written notice.

Late Fees

If full payment is not received by the advertised deadline, a late fee of \$150 to \$200 will be added to your balance. This fee will be applied after midnight on the deadline date. Travelers will not be considered paid in full until both the balance and late fee have been settled. If payment is not completed, the reservation may be canceled without refund. VP Productions reserves the right to cancel any reservation if full payment is not made after the final payment deadline.

Cancellation and Refunds

- **Non-Refundable Deposit:** All deposits are non-refundable.
- **Cancellation Requests:** Must be made in writing (via email).
- If a room or group size is reduced, any loss of deposits or payments is not transferable to the remaining balance or future trip.
- VP Productions reserves the right to cancel any reservation, in which case a full refund will be issued.

Cancellation Policy Based on Timing

- **More than 91 Days Before Departure:** All payments, except for the non-refundable deposit, are refundable if cancellation is requested more than 91 days prior to the departure date.
- **Within 90 Days of Departure:** All payments and deposits made to VP Productions are non-refundable if cancellation occurs within 90 days of the departure date. **No exceptions.**

Flight, Aircraft, and Delays
